2. Your personal data will be stored for the purposes related to carrying out all the activities connected with your participation in the New Hope of Jazz Competition 2025; your personal data is processed by the Controller pursuant to Art. 6 GDPR;
3. The categories of personal data include: name, surname, date of birth, telephone number, e-mail address;
4. Your personal data may be transferred to authorised bodies in accordance with current legislation;
5. Your personal data will be stored for the period necessary to carry out all the activities related to holding the New Hope of Jazz Competition 2025 and after this period if the Organiser will be obliged to do it under separate legal provisions.
6. The Organiser provides you with the implementation of the rights resulting from the GDPR, i.e.
